LaPrade, Lietman, and Yamaguchi Receive Career Awards



DALLAS, TX - During its semi-annual Board of Trustees meeting on Tuesday, February 12, 2002, Board members approved this year's grants and awards recipients.

One of the researchers to receive a Career Development Award that provides \$75,000 per year for three years was **Robert F. LaPrade, M.D.** of the **University of Minnesota**, for his project, *The Natural History and Outcomes of Posterolateral Knee Complex Instability: An In Vivo Model.*

In a survey of the new recipients, **Dr. LaPrade** commented that he hopes his research can provide "early recognition by clinicians of posterolateral knee injuries, and improved methods to treat posterolateral

and multiple ligament injured knee injuries."

Dr. LaPrade, an Associate Professor in the Department of Orthopaedic Surgery and the University's Sports Medicine Institute, credits the OREF C a r e e r Development Award with assisting in the

project's funding, and allowing for research to be the primary focus of his biomechanics

lab.

In addition to **Dr. LaPrade**, two additional Career Development Award recipients are **Steven A. Lietman, M.D.** of **Johns H o p k i n s**

University, for his project, *Molecular Mechanisms of Ectopic Bone Formation*, and

Ken Yamaguchi, M.D., of **Washington University**, who received the Thomas M. Coffman Career Development Award for his project, *Natural History of Asymptomatic Rotator Cuff Tears: A Longitudinal Study of Contralateral Tears Detected Sonographically.*

Zimmer Funds Orthopaedic Development Awards

Zimmer Holdings, Inc., announced that it has funded more than \$300,000 in unrestricted grants to seven orthopaedic surgeons who are early in their careers and are pursuing further training or investigation. From the Board Chair

It is a very good feeling to know that OREF is poised to become an even more significant part of the orthopaedic community in the years ahead, and that it is building on a pattern of success in doing so. The past year was the second best year OREF has ever had in terms of total dollars raised, including planned gift commitments. The prior year, 2000, had been our second best year, so we have been topping ourselves. We received gifts and pledges of \$8.7 million, and another \$2.7 million in planned gift commitments. We were able to fund 102 grants worth more than \$3.25 million this year, our best year for grant support ever.

At the Annual Meeting of the AAOS, we announced the creation of our first Clinician Scientist Award, to be funded by **Zachary B. Friedenberg, M.D.**, and his wife **Kathleen**. We hope this will be the example for more such awards in the near future.

This success has given us momentum for our future efforts. During the meeting in Dallas, the OREF Board reviewed the draft of our strategic plan, intended to put OREF in a position

to triple (or more!) its endowment in the next several years. That plan focuses on enhancing our communication efforts, both within and outside of the specialty, on verifying the impact of our work over the past 47 years, and on building partnerships with orthopaedic surgeons, professional organizations, and the public in order to raise the money needed to get our endowment to our goal.

These have been very exciting years for OREF. The next few years will be more exciting yet. I hope each of you will join us in our journey. It'll be worth it for us, our specialty, and our patients.



A Message From the President



I was going to begin this article by writing that these are very exciting times at OREF, but the truth is that every day at OREF is exciting. We completed the end of the year giving push in January but then headed right into the AAOS Annual Meeting in Dallas in February. Now we are fully into the grants cycle, having announced our grants awards categories and are now accepting applications. This will continue for the next several months as highquality grant applications arrive daily. By September, boxes full of application materials will be ready for review by our many volunteers. (Thanks to them for the wonderful work they do for OREF!) We are also hosting several Resident Symposia in various parts of the country during the spring term. These give us a chance to encourage young doctors to participate in a research and presentation activity.

Fund raising continues throughout the year, and we have already begun receiving many gifts from orthopaedic surgeons renewing their annual Order of Merit (\$1,000 or more) gifts. The Shands Circle Committee is busy recruiting new members, and we hope to add as many as the more than 30 new members we welcomed last year.

We are also working with several of the specialty societies on ongoing campaigns, or in some cases to begin planning a campaign for them. Our work with COMSS groups is extensive, including everything from initial planning, to goal setting, prospect identification, drafting of fund raising letters and supporting materials, and management of the funds raised. We also help these groups by offering assistance on grant reviews if needed, and on distribution of funds once decisions about their use are made. We really try to be a valuable resource for all groups connected to orthopaedic medicine.


Another significant component of our financial support comes from industry,

and we work closely with corporate supporters to examine ways to increase their support at a time when some companies are cutting back on their contributions. By being flexible and responsive to the companies who support us, and exploring new ideas for research that meets both their needs and ours, we are getting great cooperation from orthopaedic industry once again.

We have determined that we need to do a better job of telling the story of what OREF research has meant over the years, so we are making a commitment to explore the history of OREF to document the impact that the research and researchers connected with OREF have had on orthopaedics. While we are looking to our past, we are also trying to ascertain the future, looking ahead to try to determine what the future of orthopaedics might be in five or ten years so that we can better align our research to important new trends, putting us on the cutting edge. In addition to all of this activity, we are also making sure that we manage your gifts to us in a professional and responsible way. Our Finance Committee meets quarterly to review our investments, and we just completed our annual audit process.

So, if you were to ask "what's new at OREF?" the response would be "In what area?" In individual giving, Shands Circle recruitment, work with specialty and other societies, corporate giving, grant-making, or financial management, there is always something exciting going on. And we know that the effort is worth it, because at the end of each fiscal year we see how much support OREF has, and when grants are announced we see how important the research is. We hope that you will join us in our efforts throughout the year to continually enhance the quality of life provided by orthopaedic surgeons.

Annual Giving Update

I am writing you on behalf of the Orthopaedic Research and Education Foundation (OREF). I serve on the Board of Directors, serve as Vice Chair of Development, have supported OREF annually since 1987, and have been a member of the Shands Circle since 1994.

Since 1955, OREF has funded 1,625 grants for a total of \$47.5 million. Thanks to contributions received in 2001, this year 102 grants are being funded for \$3.25 million.

The events of 9/11 and the economy impacted gift giving. Although OREF's total income was up, contributions to the Annual Fund were down nearly \$300,000. There was a reduction in 300 total donors and a reduction of 200 donors at the Cum Laude (Order of Merit).

The impact was terrible. After the driver's bag deflated, I opened the door to get as far away from the truck as I could. Once free, I could hear the emergency vehicles coming while I was standing on the corner surveying the damage. When the Livonia Fire Department arrived, they took me to the emergency room.

Once I was in the ER, doctors checked for any damage from the air bag deployment. My right hand was in extreme pain at that time and my back was sore. After many X-rays of my right hand it was determined I had a fracture of the "Snuff box region." They put a cast on my hand and arranged for me to see an orthopaedic surgeon for follow-up care.

After a call to my internist, I was referred to **Dr. Thomas J. O'Keefe** of the **Ann Arbor Orthopedics** in Ypsilanti, Michigan. **Dr. O'Keefe** freed me from the cast, examined my hand, and advised I had a bruised radial nerve that should heal within six weeks. I was relieved.

Throughout this experience, my brother Dan, a retired Detroit Police Officer, who during his career had experienced some serious auto accidents, advised me to "wait this out — your body went through a lot at 35 mph. That is a violent crash to withstand." He was right -- it was violent, and the damage was significant. Six weeks after visiting **Dr. O'Keefe** for the first time, I put weight on my left leg to try walking normally and it gave way.

Initially, I thought I had stepped on a rock and lost my balance; when I stood up, I realized that I had difficulty walking because my left knee gave out. I returned to **Dr. O'Keefe**.

After two weeks on Day-Pro with no results, an arthroscopy was performed, and showed a great deal of damage, **Dr. O'Keefe** "cleaned it up" and told my Mom I would require "long time care."

After three months of physical therapy at the **University of Michigan's Med-Sport** facility at Domino Farms, in Ann Arbor, Michigan, the strength in my leg was restored and I was able to return to work.

A year later I experienced excruciating back pain that was not related to the accident. Unable to walk, sit, or even breathe properly, I phoned **Dr. O'Keefe** at 3:00 a.m. for guidance. I was taken to **St. Joseph Mercy** Emergency Room in Ann Arbor, where I spent the night. The next morning I was released with painkillers and told to return to **Dr. O'Keefe**.

Dr. O'Keefe referred me to **Dr. Mark Falahee** of the Michigan Brain and Spine Institute in the Michigan Orthopedic Center in Ypsilanti, Michigan. **Dr. Falahee** ordered the usual tests (X-rays, MRI, and a painful disc-o-gram). Those tests confirmed that I had damage to the L-5 and L-4 regions. The doctor recommended spinal surgery to correct the problem.

After minimal consideration, (pain being the determining factor), I elected to have the BAK implant surgery performed by **Dr. Falahee**. I viewed a video made by **Dr. Falahee** and his staff explaining what would be done, what I could expect, and the complications that could arise from this type of procedure. Since I had chronic back pain my whole life to that date, I was willing to undergo surgery to correct my problem.

As a result of these events, I have experienced the following orthopaedic treatments:

- Arthroscopy of my left knee
- Three months of physical therapy
- Carpal tunnel release procedures on both hands
- BAK implants in L4 and L5 (spinal surgery)
- Spine surgery physical therapy
- A second arthroscopy of my left knee
- Use of a Don-Joy knee brace on my left knee

My experiences with orthopaedic medicine have been extensive, but probably no more or less dramatic than many others. Certainly it was less than some who have suffered more serious injuries. Yet, perhaps that is a reason I have chosen to become involved with the National Board and the Orthopaedic Research and Education Foundation. I know that somewhere in its history, OREF has funded research that led eventually to improved care in some of those areas, that researchers who got their start later made contributions to orthopaedic medicine by their later research and patient care, and that companies which support OREF have been involved in developing the tools and techniques that have helped me. They have helped millions of others, as well. The staff at OREF has a favorite phrase to share when they talk about how orthopaedic medicine improves the quality of life for all of us. They say, "It all begins with research." They're right - and that's why I'm not just a grateful - and active - patient. I'm also an OREF supporter. Sometime in the past people made gifts to OREF, and important research was done, and significant surgeons and orthopaedic leaders got their start as a result. Sometime in the past, the care that helped me all began with research.

So what are the facts?

• Since its founding in 1955, OREF has made over 1,200 grants totaling in excess of \$47 million. Of these totals, 120 grants and between over \$5 million has been for pediatric related research.

- Since 1992, OREF has funded 21 grants totaling over \$1.6 million for pediatric related research.
- These funds are in addition to the more than \$200,000 that has been given to OREF and directed specifically in support of the research and education activities of POSNA.
- In 1998, OREF introduced Mr. John Herklotz to POSNA and because he was excited by POSNA's mission, he provided a challenge grant of \$250,000. The membership of POSNA responded

with contributions and pledges of over \$325,000 to meet his challenge. These funds, now totaling more than \$575,000, will serve as an endowment to support POSNA programs in perpetuity.

There is an additional benefit beyond the amount of funds raised. By working in partnership, duplication of effort and overhead cost is minimized. OREF provides the fundraising support, recognition of donors, ongoing communication with donors, grants management, and money management. POSNA can therefore dedicate all its efforts to programs for its members.

I believe you will agree that the return on the investment by POSNA is quite impressive. I suspect that the same is the case for most if not all of the specialty societies currently in partnership with OREF.
