# Dr. Kuo Honors Late Wife by Establishing Endowment

iving back comes natural for **Dr. Ken N. Kuo.**Born in Taipei, Taiwan in 1940, Dr. Kuo has spent his professional life finding ways to give.
Dr. Kuo is a student, teacher, and giver of his time, talent, and treasure.

On October 27, 2001, Ken lost his wife of 34 years, Angela S.M. Kuo. Angie graduated from Deaconess Hospital Medical Technology School in Detroit, Michigan in 1969. She worked at Rush Medical Center from 1969-1972 as a biochemistry research assistant. In 1990 she became a real estate agent and was intently involved in Taiwanese community activities and other Chicagoland organizations; ultimately she served as President of the Taiwanese American Chamber of Commerce of Greater Chicago.

Angie traveled with Ken to various orthopaedic meetings and as a result developed many friends within the community. As a fitting tribute and memorial to Angie, Ken established the Angela S.M. Kuo Endowment at OREF. His generous \$500,000 commitment is in the form of a challenge grant to be directed by the Pediatric Orthopaedic Society of North America for support of high priority research and education programs.

Ken's first partner at Rush, **Dr. Jorge Galante**, remarked, "Ken has always led by example and his decision to establish the Angela S.M. Kuo Endowment at OREF is yet another example of his desire to see that others have opportunities to learn and grow. Ken has made sure that Angie's legacy will live on through this endowment. And Ken will continue to build his legacy both here and abroad through his tireless efforts to give back to the orthopaedic specialty and society in general."

Ken and Angie Kuo made the practice of medicine attractive to their three children. Eugene is an orthopaedic resident at Rush Medical Center who is

married to a pediatrician; Joyce is a pediatrician married to a US Army physician stationed in Heidelberg, Germany; and Christina is an orthopaedic resident at the Hospital for Special Surgery in New York City. Currently Professor of Orthopaedic Surgery at Rush Medical College, Rush University, Chicago, Ken (continued on page 8)

# Centerpulse Award Recipient Selected



The Orthopaedic Research and Education Foundation awarded **Debra J. Thomas,** M.D. the 2003 Centerpulse (now a part of Zimmer) Orthopedics Minimally Invasive Surgery in Joint Replacement Research Grant.

Currently a resident with The Dorr Arthritis
Institute/Centinela Hospital and King-Drew
Medical Center, Dr. Thomas will receive the
\$15,000 resident research award to study both the
physiological and psychological outcomes of
patients who have undergone minimally invasive
total hip arthroplasty. The five-month study concludes in December when Dr. Thomas reports her
findings to Centerpulse Orthopedics.

"I would just like to say 'thank you' for the opportunity to pursue research in an area of interest to me. I plan to continue to make clinical research a part of my future career in orthopaedics," stated Dr. Thomas.

Dr. Thomas also holds a bronze medal in figure skating from the 1988 Winter Olympic Games.

## **OREF 50th Anniversary Plans Underway**

During the Annual Meeting of the AAOS in March, 2005, in Washington D.C., we will celebrate that milestone with a day-long series of events designed to emphasize the importance of research to the practice of orthopaedics over the past 50 years, and to consider the potential implications of research in the next 50 years.

The AAOS has graciously agreed to let us plan this OREF Day during the annual meeting for Thursday, March 24, 2005. Our plans include our usual Leadership Breakfast at which we will honor key donors and grant recipients. For the anniversary we would like to also recognize those who had a role in the formation of OREF or representatives of their families. If it had not been for the vision and dedication of those individuals, we would not be enjoying the result of nearly 50 years of research and education in our chosen profession.

## Looking Back: The Impact of Research on Our Practice

Following the Leadership Breakfast, we will present a program on *The Impact of 50 Years of OREF Research on Orthopaedics*. We plan to highlight key developments in research and important individuals whose work has had an impact on how we practice medicine. This historical perspective is significant because it is often easy to forget how much we have advanced in a short time, and to overlook how much research has affected the ways we treat patients.

At mid-day we are planning a special luncheon symposium to honor young volunteers, donors, and researchers who we believe will shape the future of OREF, and of the specialty. Perhaps they will have an effect as powerful as that of the founders of OREF.

## **Looking Ahead: The Future of Orthopaedics**

In the afternoon we will shift gears to offer a symposium on *Discovering the Future: The Next 50 Years of Orthopaedic Research.* This will give us a glimpse of

what is on the cutting edge now and what might be in the not-so-distant future. Just think how much our specialty has changed due to new developments in implants, new surgical techniques, the growing role of pharmaceuticals in our practice, genetic research, etc. It wasn't that long ago that same-day arthroscopic procedures were unheard of, or that minimally invasive surgery was only an idea. This symposium will allow some of the best and brightest of the current generation of researchers to offer their thoughts about our collective future. This should be a very exciting and provocative session.

Finally, OREF Day will end with our traditional Shands Circle event, which will be called our *Shands Circle Gala* for the anniversary. This has become a noteworthy event each year during the Academy meeting, and for 2005 we will make it an even bigger and more impressive evening. It should encourage many potential donors to join the Shands Circle just to make sure they can attend.



The Board of the American Academy of Orthopaedic Surgeons (AAOS) has distributed the Unified Research Agenda (URA) that was produced in conjunction with OREF, the Orthopaedic Research Society, COMSS, and the Bone and Joint Decade. The burden of disease and directions for future research are identified for six leading research priorities:

- Osteoarthritis
- Spinal disorders
- Osteoporosis and bone quality
- Major limb trauma
- Soft-tissue injuries and
- Childhood musculoskeletal disorders.

Impact: Please describe the role of OREF in medical device industry research.



Impact: How do you see OREF's role in patient care?





decided in early 2003 to accept a new challenge, and an opportunity to give something back in his homeland. He accepted the position at National Health Research Institute as Executive Director of the Forum and P.I. at the Division of Health Policy Research in Taipei.

The Forum, similar to the Institute of Medicine in the United States, is a think tank for governmental public health policy and will disseminate advanced health knowledge, including medical education policy and guidelines. Ken was chairman of the Graduate Education Committee at the Forum for the last three years. When the position of Executive Director became vacant Ken was considered the best choice. As Executive Director of the Forum Ken will manage five committees in various health-related issues and continue his endeavor in graduate medical education. As P.I. Division of Health Policy Research, Ken will have assistants and funds to conduct mission-oriented research. Ken will continue his pediatric

orthopaedic practice and teaching at the National Taiwan University Hospital.
